Review of BLOs

Hook Norton – Paul Worth is happy to continue in the role and the Branch confirmed they had no issues with Paul as the BLO for Hook Norton Brewery.

Keith Rigley questioned the process by which the above had been chosen as he was not aware that the vacancies existed. It was explained that volunteers had been asked for in the Chairman's letter.

WEBSITE – separate report

GBG ENTRIES – Concern had been expressed over the number of votes needed for a pub to be placed in to the GBG, as it was felt that one person only could be responsible for any entry. As a result a proposal was put forward suggesting that the number of individuals should be increased.

The secretary reported that the Pubs Officer had asked her to raise his concerns about this proposal and inform the meeting that he felt this was not the way to deal with the issue.

Some members present felt that the number should be raised considerably, and a suggestion was put forward that pubs who received a larger number of marks should received preferential treatment. After discussion this was felt to be unfair on pubs in more difficult to reach places as this would place them at a disadvantage.

After further discussion it was proposed that any entry for the Good Beer Guide should have been marked by three different members, and any pub which would otherwise qualify should be referred to the committee to check out.

This was put to the vote and **carried** by a majority.
